

## Protection of the consumer's personal data

1. The company JUREK S+R s.r.o., registered office 73913 Kunčice pod Ondřejníkem č.p. 766, company ID 25855972, registered with the Regional Court in Ostrava, section C, entry 22353 (hereinafter referred to as "Supplier" or "Trustee" (EC) No 2016/679 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46 / EC (General Regulation on the protection of personal data) (hereinafter referred to as "the Regulation"), the following personal data:

- name, surname
- e-mail address
- telephone number
- residence address

2. The above personal data must be processed for order handling and other performance of the contract if there is a purchase agreement between you and the Supplier. Such processing of personal data enables Article 6 (1) b) Regulation - processing is necessary to fulfill the contract. The Supplier also processes these data for the purpose of recording the contract and any future application and defense of the rights and obligations of the parties. The storage and processing of personal data is for the above purpose for a period of 10 years from the implementation of the last part of the performance under the contract, unless otherwise required by the law for the maintenance of the contractual documentation for a longer period. Such processing is possible on the basis of Article 6 (1) c) and f) Regulation - the processing is necessary to fulfill the legal obligation and for the purposes of the authorized interests of the Trustee.

3. The processing of personal data is carried out by JUREK S+R s.r.o. i.e. the data Trustee. Personal data for this Trustee is also processed by Processors:

5. The Privacy Trustee, as the operator of [www.outdoor-gear.eu](http://www.outdoor-gear.eu), uses "cookies" on this Web site for the purpose of:

- the basic functionality of the website,
- tracking website traffic, and generating visitor statistics and visitor behavior on websites.

The collection of cookies for the purpose above may be considered as processing of personal data. Such processing is possible on the basis of a legitimate reason - the legitimate interest of the Trustee, and it allows Article 6 (1) f) Regulation.

6. Please note that you are entitled under the Regulation:

- to cancel at any time the sending of business communications,
- to object to the processing on the basis of the legitimate interest of the controller,
- to ask us for information about how we process your personal data,
- to request us access to these data and let them update or correct, or request processing restrictions,
- to require us to erase this personal data, we will delete the deletion unless this is inconsistent with the applicable legal regulations or the legitimate interests of the Trustee,
- to ensure portability of data when it comes to automated processing on the basis of consent or performance of the contract,
- to request a copy of the processed personal data,

- to ensure effective judicial protection if you believe that your rights under the Regulation have been infringed as a result of the processing of your personal data in violation of this Regulation,
- to file a complaint with the Office for Personal Data Protection
